SUBJECT	:	EARLY REGISTRATION FOR SY 2018-2019

- DATE : January 24, 2018
  - 1. Pursuant to DepEd Order No.1, s. 2015, No. 5, s.2016 and No. 6, s.2017, this office reminds all concerned of the Early Registration for Kindergarten to Grade 12 which shall commence on January 27, 2018 down to February 23, 2018.
  - 2. The objectives of this early registration are:
    - a. To ensure that all five (5) year old children are enrolled in kindergarten;
    - b. To ensure that learners who are in school continue their schooling;
    - c. To map household in all barangays and record information for potential enrollees of Alternative Learning System (ALS);
    - d. To locate, identify and enroll out of school children and youth who:
      - i. are in remote/ geographically isolated areas;
      - ii. belong to disadvantaged groups or who suffer from discrimination;
      - iii. have disabilities or in need of special education; and
      - iv. have dropped out but would like to go back to school.
    - e. To understand the barriers to access to education and identify local solutions or interventions to bring them to school and ensure that they do not drop out.
  - School Heads are urged to come up with various activities such as mapping/ house to house campaign or meetings with local and barangay officials and civic organizations to help and locate children who should be in school.
  - 4. Enclosure 1 contains the Monitoring and Evaluation Tool for Early Registration for SY 2018-2019.
  - 5. All schools are requested to provide the data via *Online Encoding System* every Wednesday from January 31 to February 28, 2018.
  - 6. Immediate dissemination of and strict compliance with this Memorandum is desired.
