1. Pursuant to DepEd Memorandum No. 0292, s.2018 in compliance with the Civil Service Commission Memorandum Circular No.17 s. 1989, all teaching and non-teaching personnel are required/ mandated to undergo annual physical examination.

2. The annual physical examinations will be held at Gabaldon Hall, Central School, City of Cabuyao, Laguna from April 23- 27, 2018 from 7:00am to 12nn and 1:00- 5pm.

3. All concerned are required to be involved and to partake in the activity so that it will have a higher percentage of compliance success.

4. The annual physical examinations, i.e., medical and dental exams, together with Chest X-ray film and official reading result are prerequisites for issuance of medical and dental clearances.

5. Exemption from the Chest X-ray examination will be as follows:

a. Pregnant or suspected to be pregnant personnel; however, the said personnel must submit a recommendation of exemption coming from their OB Gynecologist;

b. Personnel who has undergone a chest x-ray within 3months prior to the schedule of APE, but the x-ray film and the copy of the reading result must be submitted during the exam.

6. Personnel must be present according to their schedule to avoid commotion during the examination. Please be guided accordingly. See Enclosure 1.

7. All are required to follow the "Flow of Examination" (Enclosure 2) to be supervised by the Division Health Personnel during the schedule. During that time, an Officer of the Day may be designated to attend to your clarifications, confirmations, etc. Don't hesitate to ask them.

Immediate and wide dissemination of this memorandum is desired to assure strict compliance of all concerned.



This collaboration was formalized with the issuance of PhilHealth and DepEd Joint Circular No. 001, s. 2014 and communicated through DepEd Memorandum No. 30, s. 2014.

In this regard, all Regional Directors and Schools Division Superintendents are instructed to ensure that services that may be availed through TSeKaP are maximized by DepEd teaching personnel, particularly characterination that form part of the annual physical examination of teachers. In particular, SD-base advised as

- 1. Actively coordinate with PhilHealth in ensuring the issuance of PhilHealth Identification Numbers (PIN) to DepEd teaching personnel without PIN
- Conduct advocacy and communication activities with DepEd teaching personnel
 Put in place an efficient process of identitying and updating preferred TSeKaP providers for DepEd teaching personnel"
- 4. Ensure prompt submission of updated List of Provider Assignment of DepEd Personnel to PhilHealth
- 5. Monitor provision of TSeKaP services to DepEd personnel and regularly provi to PhilHealth on the quality of services provided
