

The Alliance of Concerned Teachers – Region IV-A Union has been granted its Certificate of Registration No. 1946 last November 7, 2014 by the Department of Labor and Employment and Civil Service Commission and the only **Registered Union** representing teaching personnel in CALABARZON

The ACT Region 4A Union will hold a 1st Regional Training of Trainers (RTOT) on April 20, 21 and 22 2018 which will be held at Teachers Camp, Baguio City.

The objectives of this important activity are:

- a. Help the teacher-leaders and future teacher-leaders in their professional growth:
- b. Help them develop to become future teacher-leaders and to be more responsible and conscious;
- Impart to them the general principles / concepts and objectives of the Department of Education (DepEd) and relay to them the important task that they should do as educators;
- d. Make them aware about the present national situation and its relation to the overall education situation of the country, and
- e. Educate them on the proper handling of issues and problems that may arise within their respective schools or their other member schools between administration and teachers, among teachers and between teachers and parents or teachers and students. The topics to be discussed during this activity include:

- 2. Teachers welfare and economic and other benefits
- 3. On Public Sector Unionism

Personalities known to be teacher's rights advocates, teacher-leader and DepEd focal person will be among our panelist during the three-day leadership training and seminar. Participants of this leg of the R LTS are selected officers and members of the teacher's federations in Region 4A, officers and coordinators of Alliance of Concerned Teachers – Region 4A Union and other interested teachers

In this regard, may we request in your good office to be our major partner for 1st Regional Training of Trainers. We request you to give an input on CPD Law on 21 of April 2018 at 8:30 in the morning. Further, we also request your good office to release a memorandum allowing teachers to attend on official time and be given two -day service credits. A registration fee of Php 1,000.00 will be collected from each participant as their counterpart to help us cover the cost of food and snacks, kits and other expenses. We further request that you indicate in the memorandum that the registration fee and transportation of the participants is charged against the school canteen funds or from the Maintenance and Other Operating Expenses of the concerned divisions.
