- 1. In compliance with DO No. 15 S. 2018 or the Supplemental Guidelines on the implementation of School Based Feeding Program for Fiscal Year 2018, this office announces the conduct of Nutritional Assessment and Weighing of learners enrolled for the School Year 2018-2019.
- 2. Schedule of Activities are as follows:
 - Checking and recalibration of Detecto weighing scale- June 1, 2018
 - Weighing of learners- June 4-14, 2018
 - Submission of Nutritional Assessment Report per School- June 15, 2018
- 3. Each school should conduct the said activity in preparation for the School Based Feeding Program for School Year 2018-2019. Each school may strategize their own ways of assessing the nutritional status of students based on the enrollment per grade level.
- 4. Coordinators are required to comply with the standard operating procedure of weight assessment to accurately gather data and obtain correct statistics for School Based Feeding Program beneficiaries.
- Nutritional Assessment Report of Schools must be submitted on or before June 15. 2018 at Gulod Elementary School during the Nutrition Coordinators Meeting for Division Level consolidation of the report.

SUPPLEMENTAL GUIDELINES ON THE IMPLEMENTATION OF SCHOOL-BASED FEEDING PROGRAM FOR FISCAL YEAR 2018

- 1. The Department of Education (DepEd), through the Bureau of Learner Support Services-School Health Division, shall implement the School-Based Feeding Program (SBFP) for Fiscal Year 2018, which aims to contribute to the improvement of classroom attendance and school performance of target beneficiaries to more than 85% per year, and encourage learners to go to school everyday.
- 2. For Fiscal Year 2018, the SBFP covers all undernourished learners from Kindergarten to Grade 6. The program shall also cover all Kindergarten learners in the Philippine Plan of Action for Nutrition (PPAN) priority areas to address stunting.
- 3. The Supplemental Guidelines on the Implementation of the SBFP for Fiscal Year 2018, and the Manual on Community Participation in Government Procurement are enclosed for reference.
- 4. DepEd Order No. 39, s. 2017 entitled Operational Guidelines on the Implementation of the School-Based Feeding Program shall also be used as reference in the implementation of the program.
- 5. This policy shall take effect immediately upon its publication at <u>www.deped.gov.ph</u> or in the Official Gazette or a newspaper of general circulation.
